Acquires new 325 bed facility to deliver cutting-edge healthcare and further cement its position as the leading healthcare provider in the Eastern region

As the 5th hospital in the eastern region, the facility further strengthens Apollo's dominant position as the largest healthcare provider there with over 1800 beds across Kolkata, Bhubaneswar and Guwahati.

This acquisition an important step in Apollo's strategy to expand in key regions through brownfield and greenfield projects. Apollo will further augment its capacity in the East by an addition of another 700 beds over the next 3 years, taking the total bed count for Apollo in eastern region to 2500.
